Stop the Ukrainian Meatgrinder?

Nearly eleven months ago, in August 2023, the <u>New York Times</u> reported that U.S. officials had estimated that some 500,000 Russians and Ukrainians had been killed, wounded, or missing in the then 18-month Ukrainian War.

Both Russia and Ukraine underreport their losses. Hundreds of thousands of additional casualties have followed in the 28 months of fighting.

In the West, the mere mention of a negotiated settlement is considered a dangerous appearament of Russia's flagrant aggression. In Russia, anything short of victory would be seen as synonymous with the collapse of the Putin regime.

Yet as the war nears two and a half years this summer, some facts are no longer much in dispute.

Controversy still arises over the circumstances of the 2014 overthrow of Ukraine's pro-Russian President Viktor Yanukovych.

Russia charges that the West engineered the "*Revolution of Dignity*"—an effort to westernize the former Soviet republic, to expand the borders of Europe right to the doorstep of Russia, and eventually to fully arm Ukraine as a member of NATO.

Westerners counter that most Ukrainians wished to be part of Europe and independent from Russian bullying—and they had a perfect right to ask to join either NATO or the EU or both despite anticipated escalating tensions.

After the heroic Ukrainian defeat of the 2022 Russian bid to take Kyiv, neither side has made any significant territorial gains.

Like the seesaw bloodbath on the Western Front of World War I, neither side has developed the momentum to force the other to negotiate or grant concessions.

As nuclear Russian threats against Europe mount, NATO is seeking to regain deterrence capabilities by boosting defense budgets, incorporating robust frontline nations Sweden and Finland, and uniting over shared concerns about Russian aggression.

Many in the U.S. cheer on the conflict as a necessary proxy war to check Russian aggression and bolster NATO's resistance.

But unlike third-party wars during the Cold War, now the Western client, Ukraine, is fighting directly against the chief antagonist of European NATO members.

Arming a proxy in a war waged against the homeland of a nuclear adversary is a new and dangerous phenomenon.

The West counts on supplying Ukraine with more and better weapons than a richer, larger, and more populous Russia.

But Ukraine's problem is not so much weapons as manpower. Nearly a fourth of Ukraine's population has fled the country.

Ukraine may have suffered some 300,000 causalities. The average age of its soldiers is over 40 years. It already lacks sufficient forces to replay the failed 2023 counter-offensive. The Russian plan of attrition is to wear down and bleed out the Ukrainian people.

In a geostrategic sense, the new alignment of Russia, China, Iran, and North Korea is starting to gain opportunistic support from illiberal Middle East regimes, Turkey, and the Islamic world in general.

The Biden administration's respective approaches to the Ukraine and Gaza wars continue to be utterly incoherent. It lectures our strongest ally, Israel, on the need for a ceasefire, proportionality, a coalition wartime cabinet, and the avoidance of collateral damage.

The administration considers the terrorist Hamas almost a legitimate state.

However, Biden and the American diplomatic establishment urge Ukraine to keep fighting without negotiations. They urge Kyiv to seek critical disproportionality through superior weaponry, including hitting strategic targets inside Russia.

The U.S. has overlooked the cancellation of Ukrainian political parties and elections by the Zelensky administration. America does not seem to care about Ukrainian collateral damage to the borderlands. And it considers the Russian government a near-terrorist state.

No one in the West, at least prior to the Russian February 2022 invasion—neither the prior Obama, Trump and current Biden administrations or the Ukrainian government itself—had considered it even possible to regain by force the Crimea and the Donbas absorbed by the Russian invasion of 2014.

Add up all these realities, and the only practicable way to avoid another near-one million dead and wounded would be a settlement, however unpopular.

It would entail the formalization of the 2014 Russian absorption of Crimea and Donbass.

Russia would then agree to withdraw all its forces to its pre-2022 borders. Ukraine would be fully armed but without NATO membership.

Both sides would agree to a demilitarized zone on both sides of the Russian-Ukrainian border. Russia would brag that it prevented its former province from joining NATO while finally institutionalizing its prior incorporation of the Donbas and Crimea.

Ukraine would be proud that, like in heroic 1940 Finland, it miraculously stopped Russian aggression. It would remain far better armed than at any time in its history and soon enjoy a status similar to that of non-NATO Austria or Switzerland.

The deal would anger all parties. But it would make public what most concede privately—and stop the ongoing destruction of Ukraine and the further slaughter of an entire generation of Ukrainian and Russian youth.

There is a great clip between Jack Nicholson and Shirley MacLaine in their 1983 film, "Terms of Endearment." After a romantic encounter, MacLaine drops Nicholson at the airport, and just before the terminal doors close behind him, she yells from the sidewalk, "I love you!" Nicholson pauses, turns, and walks back out to MacLaine, who asks, "Do you have any reaction at all to my telling you I love you?" Nicholson responds with a sigh, "I was just inches from a clean getaway."

What I wouldn't give to be just inches from a clean getaway at the end of any day in June, also known in gender-confusion circles as "pride month." If only we could get to the end of the day with just one of these distractions, but alas, our editorial team can't even get through our daybreak call without being confronted by a plethora of grossly absurd "pride month" manifestations.

A couple of typical examples this morning:

First, we confirmed that the woke commander of the Osan Air Force base in South Korea has authorized "*pride patches*" to be worn on uniforms while performing official duties. Got that?

It's not just the Air Force. Each of the service branch chiefs is dutifully appearing the Biden administration's political gender-confusion agenda with such virtue-signaling nonsense. Yes, even the Navy SEALs got in on the act with their own rainbow social media post.

The next news is, after defacing the White House by putting rainbow colors on its columns, Kamala Harris hosted the cast of "Queer Eye" and concluded the gay affair by thanking them for "meaningful conversation" and "giving my office your stamp of approval." So special!

Perhaps the failed "Border Czar" should host the families of Laken Riley, Rachel Morin, and 12-year-old Jocelyn Nungaray at the White House, the latest torture/murder victims of Biden's swarms of illegal immigrants. Harris could have painted the columns red in remembrance of the tens of thousands of American citizens assaulted by violent, illegal immigrants.

Then we learned that SCOTUS will hear legal challenges to what the Leftmedia calls "Tennessee's gender-affirming care ban" for children — or, more accurately, "Tennessee's ban on gender mutilation of children." This comes on the heels of U.S. District Judge Robert Hinkle's ruling in which he asserts: "Florida has adopted a statute and rules that ban gender-affirming care for minors even when medically appropriate. But in each case, much as with the whole month of June, the leftist cadres have upended those bedrock observances.

At Normandy, Joe Biden disgracefully used the gravesites of American Marines killed in World War I as a backdrop for a political ad suggesting that Donald Trump is a "threat to democracy," much as was Adolf Hitler. Of course, Biden is the greatest domestic threat to our Republic.

Fortunately, Biden did not insist on little rainbow flags next to the American flags at those grave markers.

On Flag Day, Nate Jackson wrote about the encroachment of gender-confusion flags on flag poles reserved for our national flag in front of every federal installation across the nation. He noted further, "The 'pride' flag's very name is detestable," and cited psychologist Jordan Peterson, who correctly asserts, "Pride is not a virtue; humility is. ... Pride is the root of all sin."

As for Father's Day... To undermine family the Demos have spent decades endeavoring to undermine the role of fathers, and the consequences have been disastrous at every level. As I have noted in detail, the lack of functional fathers in families is the common denominator for the cultural entropy in America today.

Fathers — who needs 'em? Turns out, everyone does and fortunately for some who may never have even known their fathers, there are men who serve as father figures, stepping into the gap of the dark void of fatherlessness.

So, the leftist heterophobic cult of binary gender deniers has hijacked the entire month of June to celebrate pathological degeneracy, mostly related to narcissism, and most often the result of broken families — particularly, as noted above, failed fatherhood.

Of course, another major causal factor in gender disorientation pathology is the result of homosexual predation on children, a prolific problem beyond the child-grooming kindergarten drag queens and gender-dysphoric elementary school teachers/administrators, deranged models that leftists are aggressively seeking to normalize.

Predictably, the largest concentration of gender confusion is among the most easily influenced: "Gen N," the narcissist generation; the youngest of the Gen Y

Millennials, and the oldest of the Gen Z cohort. They are also the gender-bender generation.

Supreme Court Shirks Protecting Free Speech

The justices avoided ruling against the Biden administration and its blatant actions to censor speech on social media platforms.

The U.S. Supreme Court, in a potentially landmark case with significant ramifications for Americans' First Amendment right to free speech, effectively chickened out and avoided the question altogether. Instead, on Wednesday, by a 6-3 decision, the justices decided that the plaintiffs — wait for it — had no standing and therefore dismissed the case.

"We begin — and end — with standing," reads the majority opinion written by Justice Amy Coney Barrett. "At this stage, neither the individual nor the state

plaintiffs have established standing to seek an injunction against any defendant.

We, therefore, lack jurisdiction to reach the merits of the dispute."

The case in question was Murthy v. Missouri, in which the state of Louisiana had also joined to sue the Biden administration for violating the First Amendment when federal agencies pressured social media companies to censor speech that they deemed inconvenient or unhelpful.

Constitutional scholar Jonathan Turley argues that the administration "made a mockery of the limits of the First Amendment." And the Supreme Court let Biden get away with it. In fact, the administration will no doubt take this as a license for even more censorship.

What is particularly frustrating about this ruling is that the High Court took this case after the Fifth Circuit Court of Appeals had ruled last fall that the federal government was guilty of infringing on Americans' First Amendment rights.

Ironically, Barrett seemingly recognized this but then argued, "The Fifth Circuit, by attributing every platform decision at least in part to the defendants, glossed over complexities in the evidence." She also argued that "the platforms moderated similar content long before any of the Government defendants engaged in the challenged conduct" and "continued to exercise their independent judgment," negating the plaintiffs' argument.

In other words, since every decision to censor speech on these social media platforms was not due to pressure from the government, since these companies occasionally engaged in censorship of their own volition, one cannot charge the government with violating the First Amendment.

While it appears the Court's majority had an opinion regarding the case's merits, they chose to avoid it, likely because such a view would open up a can of worms regarding government infringement of free speech.

The Court's minority, which included Justices Samuel Alito, Clarence Thomas, and Neil Gorsuch, offered a deserved and scathing dissent. Writing for the trio, Alito called out his colleagues for effectively shirking their duty to protect constitutional rights.

"What the officials did in this case," warned Alito, "was more subtle than the ham-handed censorship found to be unconstitutional in National Rifle Association of America v. Vullo, but it was no less coercive. And because of the perpetrators' high positions, it was even more dangerous. It was blatantly unconstitutional, and the country may come to regret the Court's failure to say so."

He then delved into the whole issue of coercion, which the Court's majority sought to downplay. "If a coercive campaign is carried out with enough sophistication, it may get by," Alito said. "That is not a message this Court should send." Indeed.

He illustrated this by pointing to publicly available reactions from Facebook personnel. Facebook's reactions "were not what one would expect from an independent news source or a journalistic entity dedicated to holding the Government accountable for its actions," Alito noted. "Instead, Facebook's responses resembled that of a subservient entity determined to stay in the good graces of a powerful taskmaster."

That doesn't mean Facebook isn't ideologically aligned with the Biden administration; it only responded as if it had little choice.

The New Civil Liberties Alliance, representing three doctors who were plaintiffs in the case, also blasted the decision. NCLA Senior Litigation Counsel John Vecchione called it "a bad day for the First Amendment" while noting, "The Government can press third parties to silence you, but the Supreme Court apparently will not find you have standing to complain about it absent them referring to you by name."

This is not the only social media censorship case on the High Court's docket.

However, this outcome doesn't inspire confidence that the Court will defend our

First Amendment against an oppressive government and like-minded Big Tech
entities.

Geoengineering:

A Primary Depopulation Program

Geoengineering, a controversial practice, involves manipulating the environment for human purposes. However, many argue that its current applications are not for the benefit of mankind but rather to meet the goals of the New World Order, which allegedly seeks a significantly reduced global population.

One important component of the program is climate or weather modification, the former for long-term change in the normal/average weather and the latter to create or modify a short-term event, such as storms or an increase – or decrease – in the ambient temperature. With the apparent success of the effort to reduce the influence of God in our lives, we have come to rely on "our leaders" playing God or believing that we (through them) are fulfilling the role we previously assigned to God – and doing it as well if not better! Thus, humanity has become conceited, believing that we have instrumentally had an effect on climate as reflected by what the influencers tell us humans have done in effecting "climate change," a matter that when examined closely is nothing more than the normal variability in the weather as well as short term changes in the climate that come and go with few existential consequences.

As a result, our so-called scientists believe that they have all the answers and thus feel free to attempt to modify weather and climate, having confidence in the efficacy or correctness of their actions. One major element of the current geoengineering effort is the removal of carbon dioxide (CO2) from the environment, especially as it exists in the earth's atmosphere. This is the conclusion that their contrived "*scientific consensus*" has decided is the right thing to do because CO2 is a "*greenhouse gas*" and thus supposedly warms the climate in a detrimental manner. Of course, they also believe that most CO2 arises from human activities instead of merely being a part of the earth's natural environmental processes. The percentage of the various gasses in our atmosphere is as follows:

Nitrogen: 78.1%, Oxygen: 20.9%, Argon: 0.93%, Carbon Dioxide: 0.04%, Trace Gasses: the rest.

WHO'S WHO IN OUR AIR

Nitrogen: While nitrogen is the most abundant gas in Earth's atmosphere, it only makes up 0.005% of Earth's crust in weight. Nitrogen is incredibly stable and requires a lot of energy to change forms. Even though its volume in Earth's crust is relatively small, nitrogen plays an important role in the "nitrogen cycle," constantly exchanging between the atmosphere and living organisms. That means that, of course, nitrogen is essential for life.

Oxygen: Earth has the conditions for our present forms of life to flourish because of this gas. Oxygen is essential to most life on earth, but it was once rare in our

atmosphere until small sea-going life called Phytoplankton produced it in such large quantities that our entire sea and atmosphere changed, bringing about the first "mass extinction" of existing life forms for whom oxygen was a poison! Even though nitrogen is an extremely stable gas, it is difficult to break down and use for chemical processes. But oxygen will readily take part in chemical reactions because it's an electron thief. So even though nitrogen is plentiful, we need oxygen to drive chemical reactions that produce, among other things, energy.

Argon: Argon is an inert gas; that is, it doesn't bond to other gasses or have much influence in the atmosphere while nitrogen and carbon make our atmosphere "work" because of their ability to bond with other elements. As to where Argon comes from, it is possible that as potassium radioactively decays, argon may be one of the byproducts, and the lithosphere has lots of potassium. And while Argon is not too exciting a gas, it's still up in the atmosphere at 0.93% of air volume, the most prevalent gas after nitrogen and oxygen.

Carbon Dioxide: While CO2 levels in the atmosphere are quite variable over the years (and centuries), and at present we are actually at a point where the CO2 level is far below average historically, CO2 is essential for life as we know it, and the more of it we have the greater the plant growth, which in turn supports animal life. Indeed, the earth is "greener" than it has been in a long time, something – if we believe the calls about "saving the trees" – about which we should rejoice, but obviously, we don't! The geoengineers trying to lower the already low amounts of

CO2 are thus participating in killing life, whatever term they may choose to use for that activity. The so-called "settled science" is nothing more than what the politicos and "czars" are pushing the scientists to prove at the moment to buttress their allegations. The biggest environmental crimes of all time are proceeding at the present time, and it is about time to stop being silent about it. Politicians, "bureaurats", and the media have colluded in the ongoing humongous coverup. They will brook no "back talk" or challenges to their memes and mantras which they immediately smear and besmirch as "conspiracy theories". That accusation is beginning to lose its punch as one piece of official propaganda after another is being "punched out" as deceptive and/or false.

"The Rest": The remaining portion of the atmosphere belongs to trace gases. For example, neon, helium, methane, and krypton are some of the major trace gases that make up a small part of the atmosphere. Man has also caused the presence of some trace gases, for example, chlorofluorocarbons (CFCs) and chlorine.

However, when chlorine enters the troposphere and eventually the stratosphere, it reacts with ozone (O3) essentially depleting that gas. Similar to ozone, water vapor is considered a variable gas and, as you know, the amount of water in the air is in constant flux from deserts to monsoons. The atmosphere is also affected by such "earthly incidents" as volcanic activity. One good sized volcanic explosion can release more "pollutants" into the atmosphere in a matter of hours than all of humanity can produce in a year!

Ongoing *Geoengineering: Weather control* and efforts such as cloud seeding were supposedly discontinued at some point in the past – unannounced to my knowledge! – as being ineffective! However, we later find that weather modification experimentation has continued apace all the while.

Science can never be "settled," or else it simply becomes the desired doctrine. As long as money is available to prove a point and advance a desired agenda, it will be vigorously employed in furtherance of those same "desired objectives." One result you didn't hear about arose from Project Cumulus which led to a flood disaster in England in 1952 after clouds were injected with chemicals to make them rain. The intention was ordinary rain such as Britain has in the same measure as Italy has sunshine. But, instead of April showers, disaster rained down on the populace as houses were swept away and 34 people lost their lives.

During Project Storm Fury that took place in the US between 1962 and 1971 storm clouds were injected with particulates to lead them away from the coasts where they would "dry up." Instead, the storms strayed off in unintended directions and did not dry out! "The best-laid plans. . ." as they say.

Popeye was a better-known weather modification program in which the US military deliberately provoked heavy rainfall on the Viet Cong's supply routes for obvious reasons. Many official documents and witness reports on the effort are available but the public was never officially notified.

Between 1974 and 1978, Congress approved 110 weather manipulation programs. If these programs caused any detrimental effects and Uncle Sam wanted to keep them secret, all is easily explained away with the all-purpose phrase "climate change." Thus, people never have a "new normal" to get used to since averages and "normals" are constantly changing at the bureaucratic will.

The HAARP (High-Frequency Active Auroral Research Program) is a weather modification, electromagnetic manipulation, and environmental disruption project of the US government that began in 1987. It was characterized as a "modification of regions in the atmosphere, ionosphere and magnetosphere" program. The project was initiated in Alaska but has since been expanded to worldwide applications with research stations established all over the globe. The project serves both military and civilian purposes to deflect or destroy incoming missiles, disrupt radio communications, generate storms, create heat waves and droughts, initiate tidal waves, move or extinguish storms and tornadoes, create excessive rainfall, and even create abnormal fires as we may have seen in the past several years in California, Texas, Hawaii, and Canada. These unusual blazes appear to have targeted specific objects leaving adjacent objects unscorched. All the damage wrought by the program is attributed to "climate change" and the program itself is characterized (as usual!) as a conspiracy myth. You can "haarp" on the program's baleful results all you want, but the powers-that-be are unfazed by your calling attention to the program.

Now we come to one of the most insidious and far-reaching components of the depopulation program, which is the systematic poisoning of the world's population by filling the atmosphere with a wide variety of nanoparticles and chemicals that are absorbed by living beings and slowly destroy them and/or degrade their existence.

The phenomenon of "chemtrails" – a reference to the visible, stationary streaks in the skies caused by ejections of poisons by aircraft which creates a checkerboard pattern that eventually becomes expansive enough to spread out and completely envelop the skies in a haze or light cloudiness. We have been told that these are ordinary "contrails" made up of water vapor from the burning of fuel at high altitudes, but these dissipate within minutes of creation while chemtrails linger for a long, long time! This anti-life technology involves the release of particles as well as the creation of electromagnetic fields that help to disperse the particles widely. Some of the known and variegated emissions include ethylene dibromide; virally mutated molds; mono-particles of aluminum, strontium, uranium, and barium and over 20 other metals; cationic polymer fibers with unidentified bio-active material; over 300 types of virally mutated fungi, a variety of infectious pathogens, and chemicals and drugs including sedatives. Additional harmful ingredients are apparently steadily added to the mix as new ones are being discovered. This mélange of toxins is causing blood coagulations/plaques as found in the sudden appearance of Morgellons disease, skyrocketing rates of lung cancer, asthma,

pulmonary/respiratory diseases and problems, and spikes in brain diseases and brain fog. The toxins in the air are killing bees and other pollinators, decimating insect and arthropod populations, and beaching whales. The planet's flora, including trees, forests, and grasslands, is dying, and the soil is becoming alkalized. Crops, even organically grown ones, readily absorb the toxins, so there is no escaping the assault. Every breath you take is filled with the highly toxic stew now, estimated at 2.5 microns per breath with large doses of aluminum as well.
